# **SECTION 4: FIRST-AID MEASURES**

Use only in well-ventilated areas. Due to danger of explosion, prevent leakage of vapours into cellars, flues and ditches. Ground/bond container and receiving equipment. - Specific notes/details

Vapors are heavier than air, spread along floors and form explosive mixtures with air. Vapors may form explosive mixtures with air.

- Handling of incompatible substances or mixtures
